Dear Mr Barcos,

Thank you for sending the file of proposals for new Refereeing rules to be tested at the Junior World Championship.

On advising members of Oceania Judo Union about this test, they are very uncomfortable with the short notice to coaches and athletes. Some of our team members have already left to go to training sessions on the way to Bangkok and will not learn about the new rules until their arrival only a few days before the championship.

Especially in the case where a contestant cannot grip the trousers even to make an attack, this will make a huge difference to contestants who have trained for particular techniques and will be seriously affected by this sudden change in the rules.

As i understand, the new rules have not been presented or discussed with the EC, and certainly OJU has not been previously informed or requested to make any tests on these rules.

We feel it would be better to discuss the proposal more and certainly better to give the athletes and coaches more notification when they are to be applied.
